



Parental Escort Policy at Promenade at Coconut Creek

The Parental Escort Policy will be in effect Monday through Friday, between the hours of 2:30 pm and 5:30 pm. Youths under the age of 18 must be accompanied by a parent or guardian that is 21 years of age or older. One parent or legal guardian may escort up to three youths, and at least one of the youths must be the child of the parent or legal guardian. Parents and/or guardians are responsible and accountable for the youths during their shopping trip. Anyone appearing to be under 18 years of age should be prepared to introduce Promenade at Coconut Creek Security Officers to their parent and/or guardian or present a valid I.D showing a photo and date of birth. Promenade at Coconut Creek Security Officers will enforce this program. Any person in violation of this policy who refuses to cooperate when requested to leave the property will be considered trespassing and may be subject to criminal prosecution. In addition, if an escorted youth is banned from the Promenade at Coconut Creek, the adult escort will also be banned for the same period.

Parent Escort Guidelines

- Promenade at Coconut Creek visitors under the age of 18 must be accompanied by a parent or legal guardian 21 years of age or older from 2:30 pm to 5:30 pm Monday through Friday.
- Proof of age will be required. Those who cannot produce sufficient photo identification will be asked to leave the property. Acceptable forms of ID include a valid driver's license or other state-issued ID, school, employer, or military ID.
- One parent or legal guardian may escort up to three youths, and at least one of the youths must be the child of the parent or legal guardian. Parents or legal guardians are responsible for the actions of the escorted youths.
- School groups are welcome as always, and the school should notify the Promenade at Coconut Creek Management Office in advance and ensure that groups are accompanied by an appropriate number of chaperones. The Management office will notify merchants of approved groups that are expected.
- Individuals in violation of Promenade at Coconut Creek's Parental Escort Policy (or any other posted shopping center policies, including the existing Code of Conduct) must leave the center or face disciplinary action.
- Visitors under the age of 18 who are shopping in the center earlier in the day, will need to be joined by a parent or legal guardian by 2:30 pm on Monday through Friday, or they will need to leave the shopping center no later than 2:30 pm.
- The purchase of a movie ticket does not exempt a youth from compliance with the Parental Escort Policy exiting the theater after 2:30 pm. Youths must immediately leave the property if not escorted by a parent or legal guardian.
- Employees under the age of 18 who work at Promenade at Coconut Creek will be allowed at Promenade at Coconut Creek, with pre-approval from the Management Office.
- The above rules apply to all shopping center areas, including but not limited to, the movie theater, restaurants, stores, and all parking lots.
- The Parental Escort Policy will be strictly enforced.
